English Jury Trials Within England and Wales trial by jury takes place when an individual pleads not guilty to a serious crime and, if found guilty, they face a possible sentence of considerable years' prison. Around 30,000 cases progress to full trial each year, resulting in approximately 400,000 jurors being summoned to take part.
